- 10. In case the students apply for issue of transfer certificate, the college shall issue the transfer certificate without any inconvenience to the students, except the tuition fee for the incomplete period of that year/semester, no additional fee is to be collected.
- 11. No capitation fee of any kind shall be levied by the college.
- 12. Kannada must be used compulsorily in administrative business.
- The college shall without fail submit an application for renewal of combination of courses for the year 2023-24.
- 14. Colleges which have completed five years should get NAAC accreditation immediately.
- 15. The Principal shall without fail submit the list of qualified teachers for evaluation to the Chairman of the concerned Examination Boards, failing which the affiliation of the college shall be cancelled.
- 16. Every college shall compulsorily hold at least two Governing Council meetings in the respective academic year and submit the report to the University without fail.
