

NOTE:

1. After provisional registration, you shall prepare research proposal and present in RAC as per section 16 of reference 2.
2. After provisional approval of synopsis, you shall take up the course work in the respective department for a minimum period of six months and this shall be compulsory for both full time and part time candidates.
3. Every candidate shall take a minimum duration of three years and maximum of six years from the date of provisional registration to submit the thesis.
4. Classroom teaching and learning is through regular mode only. Candidates admitted to the Ph.D. programme must complete the Ph.D. Course Work prescribed by the Department.
5. A Candidate has to put a minimum of 75% of attendance in course work failing which the provisional registration shall be cancelled.
6. Parameters for awarding marks under Continuous Internal Assessment for courses are as follows:
 - Attendance - 5% - shall be maintained by the Department.

- Assignment on Review of Literature - 5% shall be assessed by concerned Research Supervisor.
 - Presentation - 5% - shall be assessed by faculty who have engaged Course Work classes/sessions, and
 - Internal Tests - 10% - shall be assessed by faculty who have engaged Course Work classes/sessions.
7. The minimum passing marks for the course work end examination in each theory paper shall be 40 per cent and 55 per cent in aggregate including the continuous assessment marks. There shall be minimum of 20 marks for Viva-voce. But every candidate shall compulsorily attend the Viva-voce examination. The results shall be declared only on the basis of these courses.
 8. The candidate who has obtained an aggregate of 55 per cent and above shall be declared as qualified for Ph.D. registration. The candidate who has obtained aggregate marks below 55 per cent shall be declared as not qualified.
 9. The candidates, who fail to qualify in the course work end examination, shall be allowed to reappear in the said examination. There shall be no third attempt in this regard. In case of failure even after second attempt, his/her provisional registration shall be cancelled.
 10. Every Candidate shall be present in the concerned Department for a minimum of 100 days apart from course work and sign in the attendance register to ensure the same.
 11. After declaring the result, the successful candidate shall submit another application (Application-C) to the Dean (Academic), Karnataka State Open University, Mukthagangothi, Mysuru-570 006, through Chairperson of the department for issue of confirmed registration notification.
