

7. The minimum passing marks for the course work end examination in each theory paper shall be 40 per cent and 55 per cent in aggregate including the continuous assessment marks. There shall be minimum of 20 marks for Viva-voce. But every candidate shall compulsorily attend the Viva-voce examination. The results shall be declared only on the basis of these courses.
 8. The candidate who has obtained an aggregate of 55 per cent and above shall be declared as qualified for Ph.D. registration. The candidate who has obtained aggregate marks below 55 per cent shall be declared as not qualified.
