Report on the grievance addressed for the 3rd B.Com Students

Ms. Sherly, a student of 3" year B. Com has raised a complained against 6 boys in her class for inappropriately editing a video to defame her and which has caused issues within her family. The student requested to take action against the behaviors of the boys.

Complaint details

On 9* July 2022 Ms. Sherly gave a complained to the principal that few boys in her class taken two different videos (one video is of a boy in the class making video call to his friend and other is a reel of Sherly) and merged both the videos and has given an audio to it making it feel that the said boy and the girl having a conversation. When Sherly got to know about it she questioned the boys and the boys had private chat in boys own WhatsApp group using obscene language and inappropriate expressions. Someone shared the screenshot of the conversation with Sherly and her brother happened to see the video and chat and she was corrected at home. Sherly along with her brother approached the Principal requesting her to take action against the boys who were involved in it. The names of six boys are Wilson Roy, Radhakrishna. S, Giridharan. C, Arun Kumar. M, Godwin Francis. A, George . G.

Actions taken

- · An investigation was carried out to understand the facts behind the complained and found it to be apparently true.
- The accused students were asked to meet the manager and the principal along with their . parents
- The students were asked to submit an apology letter each, admitting that they have . committed the mistake and acknowledging that they will not repeat the same behavior.
- · The boys were suspended from college for three days and after being counseled by the Principal they returned to the college

Investigation details of students involved in rivalry incident that took place on 15* November 2022 around 1.30 pm near the college gate. The following observations were made after investigating with

Observations: As per the direction given by the principal the grievance committee had thorough investigation about the incident and recorded following statements:

1. Sachin Sanjay (III BBA):

Sachin began by saying that he was talking to his friends and was laughing about some lame joke. He observed Nicholas and Nakshathara of (I BCOM) having an argument with each other. He asked Nakshathra through signs what was going on between them since Nicholas was very angry on her.

In due time Nicholas turned towards Sachin Sanjay and his friends and stared at them and threatened to chop each of them, when Sachin asked why are you staring and it lead to arguments to fight a one

on one outside college campus. In meanwhile Nakshathra moved out with Nicholas to avoid fight. Around 1.25 pm when college gate was open the students started moving out. Sachin was waiting

along with his friends to have a fight. As Nicholas came out of college gate Sachin attacked him punched on his left eye and also punched thrice on his face and ran away.

Sachin received threat calls regarding this fight from unknown numbers twice and asked him to meet in various place like cox town circle and Kalpalli to have fight. Later Sachin's friend like brother sorted these call issues with concerned number who is a common friend.

Nicholas began by saying that he was arguing with Nakshathra regarding his Kannada notes which she lost on that day. He observed she was making some gestures at someone behind him he looked back and turned away. Sachin then question him "why are you staring " so he replied by saying to see who she was making signs to. Then Sachin provoked Nicholas and asked for a fight. Nakshathra tried stopping Nicholas to get into anymore arguments and they moved away.

After 1.30 when Nicholas went out of the gate Sachin attacked him and punched on his eyes and face. Nicholas stated he went blank and just sat down .He was taken on bike by two senior students to home. He avoided going home since his mother got to know about this fight through his friend. He called Rohith to check on Nakshathra and met her on the way. Nakshathra insisted him to complaint to the Principal. On his Complaint Sachin Sanjay (III BBA) was suspended for two weeks

3. Nakshathra

Nakshathra began by saying that she was having an argument with Nicholas regarding his kannada notes and saw Sachin asking her what was going on in gestures. She said nothing g in signs and he asked her again she nothing again in sign. In meantime Nicholas looked back to see who she was making signs to. The Sachin asked Nicholas why he was staring and provoked him for a fight. Then

he took him away from that place to avoid fight. 
